CLUBHOUSE AND POOL RULES

1. POOL AND CLUBHOUSE HOURS SHALL BE AS POSTED BY THE MANAGER FROM TIME TO TIME.
2. ANY PERSON UNDER THE AGE OF 18 YEARS MUST BE ACCOMPANIED BY AN ADULT RESIDENT AT ALL TIMES IN THE POOL OR CLUBHOUSE AREA.
3. NO CHILD 6 YEARS OF AGE OR YOUNGER MAY USE THE SPA.
4. THERE IS A LIMIT OF 2 GUESTS PER APARTMENT.
(UNLESS PRIOR ARRANGEMENTS ARE MADE WITH THE MANAGEMENT)
5. THERE IS NO LIFE GUARD ON DUTY. PEOPLE USING THE POOL DO SO AT THEIR OWN RISK.
6. "HORSEPLAY, RUNNING, YELLING" IN THE POOL OR SURROUNDING AREAS IS NOT ALLOWED. **NO DIVING!!**
7. RESIDENTS MUST BE PRESENT WITH THEIR GUESTS WHEN THEY ARE USING THE POOL AND CLUBHOUSE FACILITIES.
8. NO PERSON UNDER THE INFLUENCE OF DRUGS OR ALCOHOL IS ALLOWED IN THE POOL AND CLUBHOUSE AREA.
9. ABSOULTLY NO ALCOHOL WILL BE ALLOWED IN THE POOL AND CLUBHOUSE AREA.
10. NO PERSON WITH BADAGES, OPEN WOUNDS OR COMMUNICABLE DISEASES IS ALLOWED IN THE POOL OR HOT TUB.
11. BATHERS MUST SHOWER BEFORE USING THE POOL OR HOT TUB. BATHERS MUST ALSO REMOVE SUNTAN OIL, OINTMENTS AND ANY SMALL OBJECTS BEFORE ENTERING THE POOL OR HOT TUB.
12. BATHING SUITS ONLY. CUT-OFFS AND COTTON TEE-SHIRTS ARE NOT PERMITTED.
13. DIAPERED CHILDREN ARE NOT ALLOWED IN THE POOL.
14. SWIMMERS IN WET BATHING ATTIRE ARE NOT ALLOWED IN THE CLUBHOUSE.
15. TIRES, TOYS, AIR MATTRESSES, SURFBOARDS, FINS, SNORKELS, SCUBA EQUIPMENT ARE NOT PERMITTED IN THE POOL OR HOT TUB. U.S. COASTGUARD APPROVED LIFE VESTS ARE PERMITTED.
16. LIFE PRESERVERS AND OTHER SAFETY EQUIPMENT TO BE USED ONLY IN CASE OF EMERGENCY.
17. NO FOOD OR GLASS ALLOWED IN THE POOL OR HOT TUB AREAS. NO FOOD OR DRINK IN THE POOL.
18. THERMOSTATS, ELECTRICAL CONTROLS, AND OTHER OPERATIONAL EQUIPMENT ARE FOR THE EXCLUSIVE USE OF MANAGEMENT PERSONNEL ONLY.
19. AN EMERGENCY TELEPHONE IS LOCATED IN THE CLUB HOUSE.

TENANTS REFUSING TO OBEY THESE RULES SHALL LEAVE THE POOL AND CLUBHOUSE AREAS. MANAGER RESERVES THE RIGHT TO ASK ANY TENANT OR GUEST TO LEAVE.
